1. **POC:** Surfacing; playground surfacing is in need of more surfacing the black lining is showing through the mulch. Lining shall be cut and surfacing shall be 6 inches. Director agreed to purchase more mulch and a call will be made to licensing official once more mulch has been added. During inspection licensing official did observed maintenance bringing surfacing to fill in playground area. Licensing Official also notice a wooden playhouse door broken. Director agreed to remove the door from the playhouse as it is hazardous to the children by nails sticking out. completion date June 5, 2023
