Program Administration Violations Cited

1. **Out of Compliance:** At least one staff member with valid CPR/First Aid certification is onsite. (Rule 1.8.1 Page 38)
2. **Out of Compliance:** All personnel records are present and up-to-date (employment application may be acceptable). (Rule 1.6.4 Page 30)

Plan of Correction

1. **POC:** During the inspection, the licensing official observed that the facility did not have a current cpr/first aid on file. The facility has until the timeframe given to get a current cpr/first certification.

Kitchen Violations Cited

No violations cited.

Plan of Correction

1. **POC:** During the kitchen inspection, the licensing official observed boxes on the floor in the pantry. Technical assistance was given on stacking these boxes on crates or placing the items on selves. Items should not be left on the floors this includes boxes.

Nutritional Guidelines Violations Cited

No violations cited.

Playground Violations Cited

1. **Out of Compliance:** Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

Plan of Correction

1. **POC:** During the inspection, the licensing official observed that the overgrowth on the facility fence and tree limbs should be removed. The highlighter paint should be sprayed on all exposed tree roots.

Infant Classroom Violations Cited

One Year Olds - Classroom Number: 3

1. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))
2. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

Infant Classroom - Classroom Number: 3

1. **POC:** During the inspection, the licensing official observed that the diaper changing pad should be replaced to prevent a hazard or the spread of illness. This should be done by the timeframe given.

Twos Classroom Violations Cited

Two year olds - Classroom Number: 6

1. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))
2. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)
3. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)

Twos Classroom - Classroom Number: 6

1. **POC:** During the inspection the licensing official observed that the outlet covers in the facility classrooms should be covered to prevent a hazard. Some wall thermometers should be replaced as well. This should be done within the timeframe given.

Preschool Classroom Violations Cited

Preschool - Classroom Number: 5

1. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))
2. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)

Preschool Classroom - Classroom Number: 5

School Age Room Violations Cited

Afterschool - Classroom Number: 7

1. **Out of Compliance:** School age children are not grouped together with younger children in any single area during normal classroom and playground or water activities. School age children are not grouped

together with other age groups except during arrival and departure times. (Rule 1.8.2 & Rule 1.22.2 Pages 38 & 91)

2. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))
3. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)

School Age Room - Classroom Number: 7

1. **POC:** Upon arrival at the facility the licensing official the preschool children mixed with school-age children. Per the facility designee, the children were only mixed due to arrival and breakfast times. The licensing official explained that afterschool children are to not be mixed during the facility hours of operation and that they should be in their classroom or a space area of the cafeteria. It was explained that this should not occur again and that staff arrival hours should change to stay in compliance.
