Infant Classroom Violations Cited

Infant A - Classroom Number: 9

1. **Out of Compliance:** Space for creeping, crawling, toddling, and walking is available: (a) room not overcrowded with equipment, (b) time spent in strollers, swings, & bouncers is limited for infants who are awake, (c) activities that require extended sitting or standing are limited to 30 minutes, and (d) strollers only used when necessary. (Rule 1.9.6 Page 42)

Infant B - Classroom Number: 10

1. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)
2. **Out of Compliance:** Infants are held while being bottle fed. Bottles are not propped at any time. Infants who are old enough and capable of holding a bottle may feed themselves without being held. (Rule 1.18.2 Page 81)

Infant Classroom - Classroom Number: 10

1. **POC:** The facility staff will be required to hold infants while being bottle fed, unless following a parent consult, they are deemed old enough to hold their own bottles during feeding. Please note, based on observations made during the facility walkthrough, the MSDH licensing official observed infants in cribs feeding from bottles propped up by blankets. Technical assistance per Subchapter 18, Rule 1.18.2 was provided to the facility owner, the facility director, and staff present. An immediate correction onsite was made by the staff.


