2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)
3. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

### Plan of Correction

1. **POC:** During the facility review 1 staff was found with no letter of suitability. A new staff can not be in the facility with out a letter of suitability form. This staff was not left alone with children. The hire date was Monday 11, 2022. During the facility review the staff was sent home by the director. Technical assistance was giving on the director/ owner on the new amendment by the licensing official. Please submit with-in 14 days. The staff paper work for the letter of suitability has been sent off to the finger print department in Jackson.

were moved to classroom #3.
