1. **POC:** License official (LO) observe upon entering into the facility, the one year old classroom with no caregiver. LO saw one caregiver (cg) standing between two classroom leaving the one year old classroom unattended. LO asked were was the one yr old caregiver, infant caregiver stated that she was in the washroom. LO stated that she could not stand between those two classrooms. Regulation states that children children should not be left unattended at any time. As a result, this facility was in violation, of 10 children left unattended. LO observed in one year old classroom, classroom is measured for nine children, facility was over room capacity by one child. LO observed in one year old classroom, staff to child ratio was out of complaints, one caregiver with 10 one yr old, staff to child ratio for one yr old is one caregiver to 9 children (1:9) which results in classroom is out of ratio by one child.
