Plan of Correction

1. **POC:** Based on review of staff and children records, the facility failed to assure that they had a current MSDH 121 on each employee and child. Record review revealed one child lacked a current MSDH 121 shot record and one employee lacked the shot record to be on a MSDH 121 form. Person responsible is Director, Lacey Clements. Compliance due for completion of child record must be submitted by September 01, 2023. Please submit within 14 days to avoid possible monetary penalty of 50.00 per child. Please submit by Monday, August 21, 2023, caregiver # 10 shot record on a MSDH 121 form. If record is not submitted, caregiver cannot return to facility. Technical assistance was given to double check files monthly to ensure files are in compliance.
