Plan of Correction

1. **POC:** Licensing observed volunteer left alone with children without a letter of suitability. Per director, E. Jones staff information has been sent to fingerprint unit. Licensing contacted fingerprint unit and was informed that staff must complete child abuse registry form (docusign). Licensing informed director that staff/volunteer cannot be left alone with children. Licensing observed director enter the classroom.

3. **POC:** Licensing observed mixed age group in infant room. Children ages were observed 2 years-7 years of age.
