1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)
2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)
3. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

1. **POC:** During the facility review one staff was found with out a letter of suitability . This staff was not left alone with children. A technical assistance was provided with the designee on the new amendment. Please submit to licensing official with 14 days.

2. **POC:** During the record review two children were found without 121 forms. The children was not present at the facility. The children can not return to the facility with out an up-to date 121 form. Please submit to licensing official with-in 14 days.

3. **POC:** During the facility review one toilet was in need of repair in classroom #6. The licensing official will conduct a follow-up inspection with-in 14 days..The director will develop a maintenance check list to ensure that this violation is corrected.

1. **POC:** During the facility review the dish washer sanitizer was in need of repair. A maintenance check list will be put into place to ensure that all appliances in the kitchen are working properly. A follow-up will be conducted in 14 days.
