Acceptable topics for training may include: (a) health and safety, (b) child growth and development, (c) nutrition, (d) planning learning activities, (e) discipline, (f) linkages with community services, (g) communications with families, (h) detection of child abuse, (i) advocacy for early childhood programs, (j) professional issues. 1. **Out of Compliance:** A Certified Food Manager or designated person in charge is present who can demonstrate knowledge and perform duties. (FC 2-101.11, 2-102.11, & 2-103.1)

1. **POC:** Based on tour of the facility and review of records, the facility failed to have a certified food service manager. Two staff members have been registered for the class. The director will be responsible for scheduling a date for the exam within the next 30 days.
