- 1. Out of Compliance: Playground fence is less than 3 ¹/₂ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)
- 2. Out of Compliance: Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)

Plan of Correction

1. **POC:** licensing official observed large gap in fence/gate. Children should not be taken out on the playground until corrections have been made. Surfacing border-licensing official observed nails loose on wooden border that needs repaired before children return on playground. Overgrowth on playground fence needs to be removed and treated.

- 1. Out of Compliance: Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
- 2. **Out of Compliance:** Infants and toddlers classroom is provided in a separate space from older children. (Rule 1.11.1 Page 51)
- 3. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))

Preschool Classroom - Classroom Number: 1

 POC: Staff to child ratio-Based on observation the facility failed to maintain the correct staff to child ratio. There were 18 children present ages 3 year old-school age alone with 1 caregiver. The staff to child ratio for 3 year old is 1;14 this resulted in the classroom being over staff to child ratio by 4. This was corrected by calling additional staff to the facility. The director will be responsible for ensuring compliance at all times TA was provided Licensing official observed 5 children ages 3-5 year old combined in the classroom with 13 school-age children this was corrected when additional staff arrived at the facility. **Person Responsible:** Owner **Date for Completion:** 6/2/23
