The purpose for visit is for a renewal inspection.

Subchapter 8: STAFFING

Rule 18.1(C) states in part, The ~~st~~ staff-to-child ratio shall be maintained At all times.

Findings: The licensing official observed NINE (9) children with the ~~youngest~~ youngest AGE 10 months with one caregiver. This is four children over the proper staff-to-child ratio. The proper staff-to-child ratio is five children less than 1 year with one caregiver.

Plan of correction

Per Ms. Williams she thought that her staff could be 50 percent if the children were napping. Licensing explained rule 18.2(4) to Ms. Williams stating that this can only occur with the exception of children under two years of age, yet the facility would still be out of staff-to-child ratio due to mixed aged groups.

Per Ms. Williams she will make sure that she has the proper staff to maintain her ratio. Staff was observed returning from lunch.

Rule 18.1(4) states in part, During all hours of operation, A Childcare Facility staff shall be present who holds A valid CPR & 1st Aid Certification.
