1. **POC:** During walk through of facility, CCFI observed room 4 with 13 children and 2 caregivers. The age of the youngest child was 1 year old. The capacity of room 4 is 12 children. Therefore, room 4 was over capacity by 1 child. Per the director and owner they were under the understanding that it was a higher capacity room. To fix the room capacity, the director utilized room 2 that was not being used. The director split the children and caregivers from room 4 and moved some children to room 2. During second walk through CCFI observed room 2 to have 4 children and 1 caregiver. Room 4 had 9 children with 1 caregiver. The capacity of room 2 and room 4 is 12 children. At exit interview, all classrooms were in compliance with staff to child ratio and room capacity..
