Program Administration Violations Cited

1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** During the inspection the licensing official observed that the hot water was not working at any of the hand-washing sinks. Repairs must be made to correct this issue by the timeframe given. A follow up inspection will take place to make sure that the facility has hot water.

2. **POC:** Upon arrival the licensing official was informed that the director and designee listed on file were not present. Caregiver 1 informed the licensing official that she was the designee also but during the inspection the staff files could not be found. It could not be verified that caregiver 1 was the facility designee. Documentation should be submitted showing that caregiver 1 does qualify to be a designee by the timeframe given. Ms. Lewis (designee) arrived at 12:16pm and was able to get the file.

3. **POC:** During the inspection the licensing official observed how lunch for the second facility is packaged and sent to the facility. Technical assistance was given on keeping a food temperature log showing what the temperature of the food leaving facility 1 is and what the temperature of the food is once it arrives to facility 2. Also heat bags or a hot box should be used when transporting the food.
