2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. 1. **POC:** Licensing observed facility failed to have fire form #333 for 23-24 licensure year. Facility is asked to submit fire form #333 one week prior to expiration date.

2. **POC:** Licensing failed to have all staff development for 23-24 licensure year. Facility is asked to submit staff development one week prior to 01/31/2023.

3. **POC:** Facility failed to have children and staff roster on file. Facility is asked to complete a staff and children roster. Licensing will check at follow-up inspection.

1. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)
2. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

Infant Classroom - Classroom Number: 1

1. **POC:** Licensing observed electrical plugs not covered. Facility is asked to immediately cover electrical plugs.

2. **POC:** Licensing observed classroom without diapering area. Per facility owner the infant room is being renovated and the children were placed in another room temporarily. Licensing instructed facility owner that she could not utilize the classroom for infants without a diapering area. Facility provider COS provided a diapering area. Licensing observed sink in classroom.
