1. **POC:** Licensing official observed cereal in infant classroom. Appendix C (page 8) states that breast milk or formula shall be brought to the child care facility daily, ready to be warmed and fed. No cereal, juice or

other foods may be added to the infant breast milk or formula without a physician written request .

1. **Out of Compliance:** Proper room capacity maintained. (Rule 1.11.2 Page 53)

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the required room capacity for classroom 2 (building # 1). This classroom was measure for ten (10) children. There were eleven (11) children present in the classroom. This resulted in the classroom being over room capacity by one (1). Corrective violation immediately by moved a child to a different classroom.

1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)

2. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)

School Age Room - Classroom Number: 2

1. **POC:** Based on observations while touring the facility, the facility failed to maintain staff-to-child ratio in classroom # 2(building #2) with fourteen school age children.. The licensing official observed staff outside talking to the bus driver . Rule 1.8.1 (2) states in part, " children shall not be left unattended at any time." The directors /designee will be responsible to ensure that staff- child-ratio be maintain at all time.


1. **Out of Compliance:** Daily schedule is posted in classroom. (Rule 1.4.6(b) Page 18)
