1. **POC:** Rule 1.6.3 (5)-Facility had no records of monthly fire/disaster evacuation drills. Per the director, the facility has completed monthly drills but she could not locate the records during the inspection visit. Facility will submit the next three months drills to licensing official. A fire drill was completed and documented during the inspection visit on today. Rule 1.6.3 (8)-Director will notify the parents of the students with an invalid immunization form and will submit updated MSDH 121 form within 14 days.
