1. Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)
2. Proof of licensed pest control contractor is provided. (Rule 1.11.14 Page 62)

1. **POC:** During the inspection the licensing officials observed that a general deep cleaning is needed to the entire facility. This facility is to conduct a deep clean to the entire facility by the date that is given.

1. Appropriate surfing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

2. All use zones are adequate. (CPSC 5.3.9 Page 40)
3. No standing water is present on playground or in/on playground equipment or walkways. (CPSC 2.4.2.2(5) Page 10)

1. **POC:** During the playground inspection the licensing official observed that more surfacing is needed under the swings. Ms. Aldridge will make sure that surfacing is added under the facility swings.

1. School age children are not grouped together with younger children in any single area during normal classroom and playground or water activities. School age children are not grouped together with other age groups except during arrival and departure times. (Rule 1.8.2 & Rule 1.22.2 Pages 38 & 91)
2. Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)

School Age Room - Classroom Number: 5

1. **POC:** Upon arrival the licensing official observed that (3) preschool children were group with the after school children eating lunch. Ms Aldridge will make sure that her preschool children are never grouped with the after school children during the facility hours of operation. Ms Aldridge will work with her staff to develop a new lunch schedule for the children.
