Infant Classroom Violations Cited

- 1. Out of Compliance: Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
- 2. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
- 3. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)
- 4. **COS:** Cribs or other similarly commercially purchased units are approved and designated for the purpose of sleeping. Mobile infants (at least eight months of age) may be placed on a mat. Mats must be flame retardant and must be commercially purchased with a thickness of at least two inches. All cribs, sleep units, and mats must be clean and in sanitary conditions (i.e., no chips, holes, fraying, tears, or stains). (Rule 1.10.7 Page 47)

<u>Infant Classroom - Classroom Number: 2</u>

1. **POC:** Based on observation while touring the facility, the facility failed to provided daily written reports for the infants. Director will ensure that daily sheets are being conducted on a daily base.

2. **POC:** Based on observation while touring the facility, infant were observed in a bouncer in the baby crib. The director will ensure that no items are placed in infant cribs.

3. **POC:** Based on observation while touring the facility, the facility failed to maintain the staff-to-child ratio in classroom 2. There was 2 staff with 11 children; ages infant in classroom. Per regulations, the minimum staff-to-child ratio for infants is one staff to children. This was corrected by placing the oldest child in another room and the director will ensure that staff-to-child ratio is maintained.
