### **Infant Classroom Violations Cited**

#### <u>Lullaby - Classroom Number: 3</u>

- 1. Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
- 2. **COS:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

#### <u>Infant Classroom - Classroom Number: 3</u>

1. **POC:** Upon entering the infant classroom LO observed a child in crib laying on a sleep pillow and covered with a blanket. LO provided technical assistance by explaining to director and caregiver that nothing should be in the crib with infant while they are sleeping. Caregiver immediately took the sleep pillow out and removed the blanket from crib. COS April 29, 2021 LO observed while touring the toddler room, no daily reports are made available toddlers which includes liquid intake child disposition, bowel movements, and eating and sleeping patterns (Rule 1.7.4 (35) Director stated that she will have copies for each room when children goes down for naptime.

- 1. Proper staff to child ratio maintained. (Rule 1.8.1)
- 2. Daily reports are made available for toddlers and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)

#### Toddler Classroom - Classroom Number: 4

- 1. **POC:** LO observed while touring the toddler room, no daily reports are made available toddlers which includes liquid intake child disposition, bowel movements, and eating and sleeping patterns (Rule 1.7.4 (35) Director stated that she will have copies for each room when children goes down for naptime.
  - **Person Responsible:** Director / Caregiver **Date for Completion:** April 29, 2021
- 2. **POC:** LO observed while touring the toddler classroom, staff to child ratio over by one student. LO provided technical assistance by explaining that staff to child ratio must be maintain at all times. Director immediately remove the child from the toddler classroom, director kept child with her until the cook(floater)was able to finish serving food and the child was placed with the cook. Director stated that she is normally not over ratio but had two employees to quit around the same time cause her to be short on caregivers. Director also stated that she will be interviewing two candidates tomorrow. Until then LO explained to director that the child must stay with the cook or parent will have to be called to pick up child from facility.
