- 1. COS: Current license is displayed in a conspicuous place. (Rule 1.2.10 Page 11)
- 2. Out of Compliance: Facility is clean and in good repair. (Rule 1.11.1 (19))
- 3. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towels for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)
- 4. Out of Compliance: Proof of licensed pest control contractor is provided. (Rule 1.11.14 Page 62)
- 5. **Out of Compliance:** A first aid supply is kept on-site and is easily accessible to employees, but inaccessible to children. If children are transported, all vehicles are equipped with a first aid kit (see Rule 1.12.5 for recommended first aid kit supplies). (Rule 1.12.5 Page 65)
- 6. **Out of Compliance:** Facility has hot and cold water at all hand washing stations. Hot water does not exceed 120 degrees Fahrenheit. (Rule 1.11.5 (4))
