2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. Plan of Correction

1. **POC:** Base on observations and review of staff and children records, the facility failed to assure that they had a current MSDH 121 on each employee and child. Record review revealed two (2) child record's lacked a current MSDH 121 form. Person responsible for maintaining compliance on record deficiencies will be Mrs. Ida Cockrell, operator. Provider will in-fill hole with dirt and gravel. Person responsible for maintaining compliance of grounds deficiencies will be Mrs. Ida Cockrell, operator. Compliance due for completion by 08/18/2022.
