1. Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)
2. All bolts on equipment and fences are no more than two threads beyond the nut. (Rule 1.11.9 Page 59)
3. Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)
4. Equipment on playground area is age appropriate for children using equipment. (Rule 1.10.2 Page 46)
5. All toys and equipment is in good repair (i.e., not broken or deteriorating). (Rule 1.10.2(2) Page 46)

6. Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)
