### Program Administration Violations Cited

1. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)

#### Plan of Correction

1. **POC:** Provider will complete a Staff and Children Roster and have it in front of binders. Licensing official had to call fingerprint department to verify one staff had a letter of suitability. Provider will be sure to have letters printed and on file at facility. All staff have MSDH 121 on file.

### Infant Classroom Violations Cited

#### Infants - Classroom Number: 1

1. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
2. **Out of Compliance:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
3. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

#### Infant Classroom - Classroom Number: 1

1. **POC:** Provider will install hooks for children's belongings so they will not be touching by Monday, May 1, 2023 Cribs will be labeled and items stored in cribs will be removed by Friday, April 28, 2023.
