1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

1. **POC:** During the restroom inspection the licensing official observed that two toilets in the girls restroom #1 were out of order. Pre the director they are currently waiting on new toilets that has been order, once these toilets has been received they will be used to replace the current out of order toilets. The facility director has submitted to the licensing official a copy of her work order requesting for these repairs to be made.
