1. **POC:** The Director remove all items of food from that fridge. Additional fridge is in the kitchen . This refrigerator needs to be fixed and no standing water in the bottom where food is kept until the fridge is fixed properly there needs to be no food in the fridge.

1. **Out of Compliance:** All bolts and fencing twists and wires are facing away from the playground area. (Rule 1.11.9 Page 59)

1. **POC:** The facility will either remove, the access plastic and add more surfacing or they will add adequate surfacing to the top where the bags are not visible.they have till august 8,2023 to send a picture.

Infant Classroom Violations Cited

Infant - Classroom Number: 1

1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
2. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
3. **Out of Compliance:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
4. **Out of Compliance:** Sleeping infants are in view of staff and checked visually regularly. (Rule 1.9.4 Page 41)
5. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

Infant Classroom - Classroom Number: 1

1. **POC:** in the infant room, there is two caregivers with 11 infants does cause the room to be over ratio about one infant the child was taken to the next classroom to put the classroom in compliance. The Director license official walk together inside the infant room and went over beds being placed in the proper area labeled and all other items taking out of the cribs that do not belong inside the cribs. The only items that will be left inside the crib is the baby. The facility has till July 31 to move cribs into the proper area send a picture to the licensing official and remove all unnecessary items. all cords must not be accessible to the children at any time .

1. **COS:** Appropriate individual rest equipment is provided and must be: clean, covered with waterproof cover, and sanitized immediately if soiled or at least weekly after child's use. Preschool Classroom - Classroom Number: 5

1. **POC:** Caregiver sent one child to the bathroom, which is located outside the classroom by herself. The caregiver understands that she cannot send any children to the bathroom alone. The classroom usually has two teachers However, the other teacher was gone to lunch during nap time and a child needed to use the restroom. Technical assistance was given to the teacher and to the Director making sure there is another person to allow the child to go to the restroom, if needed during nap time or all, children will need to be lined up and take him to the bathroom at the same time.
