1. **Out of Compliance:** Proper room capacity maintained. (Rule 1.11.2)
2. **Out of Compliance:** A private, sanitary place, which includes an electrical outlet, comfortable chair, and access to running water, is provided for breast-feeding mothers. Breast milk must be properly stored in a refrigerator and labeled with child's name and date of expected expiration of milk. (1.18.7 Page 81)

The MSDH licensing staff met with Jamesia Archie, Director. A walkthrough for both trailers were conducted. There was operational electricity and water connected to the trailers during the walkthrough. Each building has one toilet and one hand washing sink. The diapering stations have been placed in the restroom areas. In trailer #1, there were 2 facility staff with fifteen one to two year old children and in trailer #2, there were 2 facility staff with 13 one to two year old children. 
