- 1. Out of Compliance: All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)
- Out of Compliance: All staff members have mandatory 15 contact hours on file (no more than five hours of in-house training may be provided by the child care facility. Acceptable topics for training may include: (a) health and safety, (b) child growth and development, (c) nutrition, (d) planning learning activities, (e) discipline, (f) linkages with community services, (g) communications with families, (h) detection of child abuse, (i) advocacy for early childhood programs, (j) professional issues. (Rule 1.5.8 Page 25)

Plan of Correction

POC: POC: POC: Rule 1.5.2(3,b) states in part, 'The facility owner and each employee shall have a criminal history records check (fingerprint). child abuse registry checks, and sex offender registry checks completed at least every five (5) years." Based on observation during the records review, the facility failed to have a valid letter of suitability for two (2)employee during the inspection. Beginning July 1, 2022, anyone without a valid letter of suitability issued by the MSDH-Fingerprint Unit will not be allowed to work in a childcare facility. The licensing official called the Fingerprint Unit. The Fingerprint Unit confirmed caregiver #2 does not have a current Letter of suitability. The staff was informed she could not return to the facility without a current Letter of Suitability. Staff #11 on the roster was not at the facility. Caregiver # 10 was called in to replace caregiver #2. This violation was corrected on-site.
