The purpose of this visit was to conduct a virtual renewal inspection.

The following was observed:

TA was provided on Rule 1.11.4(6) Thermometer shall be present in the freezer, and refrigerator.

POC: The LO provided TA by explaining to the director there must always be a thermometer present at all times. The director stated that she will be sure to replace the thermometer and monitor weekly along with kitchen staff to make sure there is a working thermometer present at all times.

LO had received all items needed for renewal.

Class I and II violations may result in a monetary penalty. Repeated violations may result in the doubling of a monetary penalty, suspension or revocation of the license.
