1. **Out of Compliance:** Facility has a qualified Director or Director Designee onsite. (Rule 1.5.3 Page 22)

Plan of Correction

1. **POC:** The licensing official observed that there was no qualified director or designee on-site when licensing official entered the facility. The licensing official met with Cha'Koreia Holmes. Per Cha'Koreia, Mrs. Carlene was at the doctor's office. Cha'Koreia called Mrs. LaKesha Holmes on the telephone, and per Mrs. Holmes, she said Mrs. Carlene was on her way. A qualified director or designee must be on site of the child care premises.

1. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

Plan of Correction

1. **POC:** The licensing official observed 6-9 inches of surfacing is needed under and around playground equipment. 6-9 inches of surfacing is needed before children utilize the play area; under and around any

playground equipment where the children's feet leave the ground.

1. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)

Infant Classroom - Classroom Number: 2

1. **POC:** The licensing official observed there was no classroom wall thermometer present. A Classroom wall thermometer is needed on the interior wall of the classroom.
