The purpose for this visit was for a renewal inspection and technical assistance.

Subchapter 25: Hearings, Emergency Suspensions, Legal Actions, and Penalties
Deficiency: Rule 1.25.9(21) states in part, "Failure to have proper (up-to-date) immunization documentation in each child's file."

Findings: The licensing official observed during the records review that (1) child did not have a MSDH 121 form on file.

POC: Sylvia Barber will be responsible for contacting the parent to submit a MSDH 121 form. The facility has (14) days from today's date to submit

(1) MSDH 121 form to the licensing official to avoid a possible monetary penalty.
TA: Technical Assistance was provided on Rule 1.25.9(21) Immunization

Class I and II violations may result in a monetary penalty. Repeated violations may result in the doubling of a monetary penalty, suspension or revocation of the license.
