1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** During the facility review the hot water in classroom #6 in the boys bathroom was in need of repair. A follow-up will be conducted in 14 days.

- 2. **Out of Compliance:** Proper hot holding temperature (135°F or higher). (FC 3-501.16)

1. **POC:** During the facility review the stove was in need of repair. The stove door would not close properly. The stove latches had come off causing the stove door to come open while the stove is hot. A follow-up will be conducted in 30 days.
