1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)

Plan of Correction

1. **POC:** Letter of suitability-based on observation during record review, the facility failed to renew/conduct the required criminal history records check, for 2 employees. These 2 employees were alone in separate classroom providing unsupervised care to the children. This was corrected by the owner going in one classroom and the director going in the other classroom. These two workers will not return to work until a valid letter is on file at the facility and a copy is sent to the licensing official. Same deficiency cited on 7-6-22.

1. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

1. **POC:** Surfacing-playground surfacing is in need of more surfacing the black lining is showing through the mulch. Lining shall be cut and surfacing shall be 6 inches. Director agreed to purchase more mulch and a

call will be made to licensing official once more mulch has been added.
