1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

- 2. POC: Rule 1.6.1 states "Records listed in this section shall be kept within the physical confines of the child care facility and shall be made available to the licensing agency on request." The facility did have the staff notebook containing the Letters of Suitability and 121s for the staff available and accessible. However, staff and children files were located in a locked office. The Assistant Director did not have access to the files in order to complete the inspection. Owner/Director Ms. Deneaka Alexander will take steps to ensure that all all staff and children files are available and accessible to Director/Designee in her absence.
