Toddler - Classroom Number: 2

1. **Out of Compliance:** Extension cords are not accessible to children. (Rule 1.11.1 Page 53)
2. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)
3. **COS:** Daily reports are made available for toddlers and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
4. **Out of Compliance:** Extension cords are not accessible to children. (Rule 1.11.1 Page 53)

Toddler Classroom - Classroom Number: 2

1. **POC:** During the classroom inspection the licensing official observed that the air conditioner cord is accessible to the children in the classroom. The licensing official did observed a colorful board covering the wall outlet where this cord is plug in. Technical assistance was given on placing a high board in front of the cord that is exposed and the wall outlet to prevent a hazard.

2. **POC:** During the classroom inspection the licensing official observed that the child's daily reports has not been started for that day. Technical assistance was given on starting the children daily report when they first arrive at the facility and making sure that what they do throughout the day is noted and sent home to their parents each day.


