3. **COS:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
4. **Out of Compliance:** Daily reports are made available for toddlers and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)

Toddler Classroom - Classroom Number: 2

1. **POC:** License official observed in classroom several items not: daily schedule, evacuation plan. Also no daily sheets were available for caregiver to record daily activity. Director stated that she will have all posted items up before the end of the work day today, April 14, 2022. A picture of posted items can be emailed to license official. License Official (LO) observed in one year old classroom the belonging of one child was touching the belongings of another child. LO provided technical assistance by explaining to director and caregiver (cg) that the belongings of one child can not touch the belongings of another child. Director stated that she will discuss violations with the caregiver. Also cg separated all the children belongings immediately. This violation was corrected on site.


