3. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)

1. **POC:** While touring the facility, the facility failed to maintain the minimum staff-to-child ratio in Classroom 2. There was 1 staff with 13 children; ages infant to 3 years -old. Additional technical assistance will be given to the facility in regards to ratio and capacity.

2. **POC:** While touring the facility, the facility failed to maintain the required room capacity for classroom 2. The classroom was measured for 5 children. There were 13 children present in the room. Additional technical assistance will be provided to the facility in regards to room capacity.

3. **POC:** Based on observation the facility, failed to provide daily written reports for children under the age two. Additional technical assistance will be provided on completing reports for children under 2.
