### Program Administration Violations Cited

1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)

#### Plan of Correction

1. **POC:** Subchapter 5 Personnel Requirements Rule 1.5.2 (1) Before a prospective staff member may begin work in a child care facility a valid letter of suitability must have been issued by the MSDH Criminal Records Check Unit. (3b) The facility owner and each employee shall have criminal history records checks (fingerprint), child abuse registry checks, and sex offender registry checks completed at least every five years. Findings: During the review of the staff records the licensing official observed (6) new employees without a FBI letters on file. These employees were left unattended with children. The licensing official also observed (8) staff with expired FBI letters on file. Due to the number of employees missing FBI letters phone calls were made to parents so that children could be picked up early from the facility. This facility is not allowed to reopen until all staff have a valid letter of suitability on file.

### Playground Violations Cited

1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)

#### Plan of Correction

1. **POC:** During the inspection the licensing official observed that the fence was missing the gates at both entry/exit ways. Per the facility director they are in the process of getting new gates and they should be installed within the next few days. This should be completed by the timeframe given.

1. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

Infant Classroom - Classroom Number: 1

1. **POC:** Technical assistance was given on removing a pillow from inside a crib where a child was asleep. The caregiver was informed that only the child and a fitted sheet is allowed in the crib.
