Infant Classroom Violations Cited

Infants - Classroom Number: 3

1. **Out of Compliance:** Appropriate individual rest equipment is provided and must be: clean, covered with waterproof cover, and sanitized immediately if soiled or at least weekly after child's use. Rest equipment

must be spaced a minimum of 24 inches apart. A minimum of 36 inches is recommended. (Rule 1.10.9 Page 47)

2. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)
3. **Out of Compliance:** Infants are held while being bottle fed. Bottles are not propped at any time. Infants who are old enough and capable of holding a bottle may feed themselves without being held. (Rule 1.18.2 Page 81)

Infant Classroom - Classroom Number: 3

1. **POC:** Infants will be held while bottle fed. Infant was observed in seat with blankets propped while staff was holding bottle. Blankets observed in cribs will be removed and not returned to cribs. Infants observed asleep in swings will be removed and not allowed to sleep in swings nor anything other than crib/mat. Cereal was observed in infant bottle with formula. Director will be sure no bottles have cereal, etc mixed in with formula. Cribs are not 24 inches apart. They will be repositioned. Fitted sheets will be placed on crib mattresses.
