### Program Administration Violations Cited

1. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)
2. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

1. **POC:** The facility has 7 days to submit expired children 121 forms

2. **POC:** The facility has to place a hand washing sink in the preschool classroom because their are diaper wearing children in this class

## Infant Classroom Violations Cited

### Infants - Classroom Number: 4

1. **COS:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
2. **COS:** Proper room capacity maintained. (Rule 1.11.2 Page 53)
3. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
4. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)

### Infant Classroom - Classroom Number: 4

1. **POC:** Upon arrival to the facility classroom the licensing official observed that the facility teacher has six infants. This put the teacher over by 1 child. The facility was able to move the oldest child into the toddler classroom in order to maintain the correct staff to child ratio. Per the facility director the other teacher that is normally in the infant classroom was not able to come to work due to personal reasons. Technical assistance was given on maintain the current staff to child ratio at all times.

## Toddler Classroom Violations Cited

### Toddler - Classroom Number: 2

1. **COS:** Proper staff to child ratio maintained. (Rule 1.8.1)
2. **Out of Compliance:** Room is well lighted, ventilated, and free of hazardous or potentially hazardous conditions. (Rule 1.11.1(9) Page 51)
3. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

### Toddler Classroom - Classroom Number: 2

1. **POC:** Upon arrival the licensing official observed 11 one-two year olds in the facility classroom. The youngest child in this class is one putting the facility teacher over by 2 children. During the inspection the teacher moved 2, two year olds into the preschool classroom in order to maintain the proper staff to child ratio. Technical assistance was given on maintain proper staff to child ratio through the facility hours or operation.

2. **POC:** During the inspection the licensing official observed that the air is out throughout the facility. The temperature in the facility is 80 degrees. It was also observed that the facility maintenance person was there working on the air. Fans were located throughout the facility classroom placed in areas that are out of the children reach keeping the classrooms cool. Technical assistance was given on maintaining a cool environment for the children due to the weather and also taking other needed steps in case the air can not be fixed on today. By the end of the inspection the facility air has been fixed and a copy of the invoice was given to the licensing official.

## Preschool Classroom Violations Cited

### Preschool - Classroom Number: 3

1. **Out of Compliance:** Room is well lighted, ventilated, and free of hazardous or potentially hazardous conditions. (Rule 1.11.1(9) Page 51)
2. **Out of Compliance:** Child's hands are washed: (a) before and after eating, (b) after using the toilet or diaper change, (c) after playing on playground, (d) after handling pets, pet cages, or other pet objects, (e) whenever hands are visibly dirty, (f) before going home. (Rule 1.12.3 & 1.18.1 Page 64)

Preschool Classroom - Classroom Number: 3

1. **POC:** During the inspection the licensing official observed that a diaper changing station is needed in the preschool classroom due to some diaper wearing children being present. The licensing official observed that the teacher line the children up and use the restroom in the hallway and that she is working on potty training some children. Due to there being diaper wearing children in this classroom a hand washing sink and diapering area is needed in the facility classroom.

1. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)
