Program Administration Violations Cited

1. **Out of Compliance:** Current menu is posted. (Rule 1.4.6(C) Page 18)

Plan of Correction

1. **POC:** Facility failed to have current menus posted. The same menus from last inspection was posted. The Owner/director stated she just cooks what she has. Owner was informed she must follow menus she has posted. Director stated this would be corrected by Monday, October 31, 2022. She will post current menus and follow them. Licensing official recommended the Designee retake the three mandatory courses and director stated the designee has too much going on right to be taking any courses.

1. **Out of Compliance:** An approved menu posted in the food preparation area.
2. **Out of Compliance:** Are there any substitutions shown on menus? (These shall be of comparable food value and shall be recorded on the menu and dated)

Plan of Correction

1. **POC:** Approved menus are not posted in area. Substitutions are not notated on menus. The facility was not serving what was on menus. These deficiencies were cited during last inspection conducted on 9/30/2022. Owner stated she would post the approved menus and to also begin notating substitutions on menus. Owner/Director was informed licensing official recommends her taking the menu writing training.

Playground Violations Cited

Plan of Correction

1. **POC:** licensing official observed children on playground. Children ages were one to three. One staff was present with 12 children. Rule 1.8.2(3) states in mixed groups, the age of the youngest child in the group determines the staff-to-child ratio. This staff should have had only 9 children. This was corrected once director/owner came and got five children from playground. Technical Assistance was provided to Owner/director concerning maintaining ratio. Director stated she tries but we (MSDH) have too many rules for her to be trying to follow.

Preschool Classroom - Classroom Number: 3


