- 1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)
- 2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)
- 3. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

1. **POC:** During the faclity review 3 staff on the current roster did not have letters of suitablity. The staff was not present at the faclity. Please submit to the licencing offical within 14days. The director has a breach of service. The director letter of suitablity is expired and have and the letter of suitablity has another faclity name. The director can not be left alone with children until a new letter of suitablity is on file. The staff letters of suitablity has been sent to the MSDH.

2. **POC:** During the facility review the toilet was in need of repair in the back bathroom. The director/owner will be responsible for ensuring that the toilet is in need of repair. A maintenance policy will be put into place to ensure that all repairs are made. Please submit maintenance policy to the licensing offical within 14 days.

3. **POC:** During the record review 5 staff was observed with no 121 forms. Staff with out 121 forms can no be at the facility. During the record review 7 children where found with out valid 121 forms. Children with out 121 forms can not attend the facility. Please submit to the licensing offical with-in 14 days. A letter for parents will be sent to each parent asking for a current 121 for for each child. Children without a valid 121 form can not attend the facility.

- 1. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
- 2. **Out of Compliance:** Child's hands are washed: (a) before and after eating, (b) after using the toilet or diaper change, (c) after playing on playground, (d) after handling pets, pet cages, or other pet objects, (e) whenever hands are visibly dirty, (f) before going home. (Rule 1.12.3 & 1.18.1 Page 64)
- 3. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)

Infant Classroom - Classroom Number: 5

1. **POC:** The director/. owner will be responsible for ensuring that each child bottle is labeled and dated daily. All teachers will review rule 1.18.1 page 81 labeling and dating bottles. A policy will be put into place to ensure all bottles are labled and dated at all times.

2. **POC:** The director/ owner will be responsible for ensuring that individuals hooks are placed in class room # 5. The infant bags where all placed in one crib. Please put a platic bag over each bad until hooks can be installed for each individual infant. Infant bags can not tough at any time.

3. **POC:** During the facility the teacher was observed not washing her hands or infant hands during toileting/diapering. A review of rule 1.18.1 will be reviewed with all staff. A staff meeting will be conducted to ensure that all staff are aware that hands has to be washed during toileting/diapering.

- 1. **Out of Compliance:** Child's hands are washed: (a) before and after eating, (b) after using the toilet or diaper change, (c) after playing on playground, (d) after handling pets, pet cages, or other pet objects, (e) whenever hands are visibly dirty, (f) before going home. (Rule 1.12.3 & 1.18.1 Page 64)
- 2. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

<u>Toddler Classroom - Classroom Number: 4</u>

1. **POC:** During the facility review the staff was observed not santizing the changing station during the facility review. A review of rule 1.16.1 will be reviewed with all staff. The changing table station should be cleaned and santized between each child.
