- 3. **Out of Compliance:** All personnel records are present and up-to-date (employment application may be acceptable). (Rule 1.6.4 Page 30)

Plan of Correction

1. **POC:** A updated alphabetical staff roster will be completed and sent to licensing official by Friday, June 9, 2022 -close of business. Applications, qualifications, and documentation of new employee orientation will be placed in employees' files that were missing them by Monday, June 13, 2022. MSDH reporting notice will be posted in facility by tomorrow June 10, 2022. Two staff with an expired letter of suitability (under amended regulations) will have updated letters by June 30, 2022. One staff (Director) with missing MSDH 121 shall not return to facility until a valid form is on file at facility. Provider must send licensing official form within 14 days.
