1. **POC:** During observation of the infants classroom LO observed, there were no bottles in the refrigerator, LO questioned the caregiver where are the infants bottles, the caregiver stated bottles were prepared in the classroom. The owner stated parents said the type of formula used for the infants would expire two hours after formula is mixed with water. LO showed the owner in Regulations Appendix C Nutritional Standards, "Breast milk or formula shall be brought to the child care facility daily, ready to be warmed and fed. Each bottle shall be labeled with the infant's name and the date. PerThe director spoke with all parents and starting the parents will start preparing bottles at home. Technical Assistance: Have the parents to prepare enough bottles to sustain the infants during the day while at the facility. Parents are to label the infants names on all bottles brought to the facility.

1. **POC:** During observation LO observed there were 12 mixed one and two year olds in this classroom. This made this classroom over capacity by 3, due to the youngest child in the classroom being one year olds staff to child ratio is 1:9. The director corrected this deficiency right away, by removing 3 older two year olds out of this class and placing them in the three year olds classroom. Technical Assistance: Make sure staff to child ratio is maintained at all times, especially when there is a chance to rearrange a classroom.
