1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)
2. **Out of Compliance:** Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)
3. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)
4. **Out of Compliance:** No standing water is present on playground or in/on playground equipment or walkways. (CPSC 2.4.2.2(5) Page 10)
5. **Out of Compliance:** Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

Plan of Correction

1. **POC:** The owner will have maintenance to come out and fix the following violations: 1. Fence has broken areas throughout it and has openings/entrapments. 2. Trash is present on playground. 3. Surfacing is

inadequate throughout play area and around play equipment. 4. Standing water is present 5. Tree limbs and grass overgrowth is present on fence. Surfacing will be purchased and replenished throughout playground. Staff will be assigned to remove trash from playground and daily playground check will be conducted. Fence will be repaired, limbs will be cut and grass/brush overgrowth will be removed from fence.


