2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)

### Plan of Correction

1. **POC:** Rule 1.6.3 (3)-Facility had no updated staff roster. Licensing official informed owner/director an alphabetical staff roster must be in the facility binder at all times and must match records on file (MSDH 121 forms and letter of suitability). Staff roster must include full name, date of birth and date of hire. Rule 1.5.2 (1)-Staff shall not start until a valid letter of suitability is provided. Licensing official observed 1 staff with no letter of suitability on file. Licensing official informed owner/director staff must leave the facility immediately. Staff shall not return back to work until a valid letter of suitability is provided. Staff was present during inspection visit. Owner informed staff to leave and will submit fingerprint cards today. Date of completion: 6/14/2023 Rule 1.6.3 (8)-Owner will notify (2) staff of expired MSDH 121 form. Staff was present during inspection visit. Licensing official informed owner staff cannot return back to work until a valid MSDH 121 form is provided. Date of completion: 6/14/2023

The playing of soothing music in the infant and toddler area is acceptable. Licensing official recommended facility to unplug the video and keep audio plugged in. Per the owner, the facility will purchase a tv sleeve to cover the tv screen. If noted again, licensing official will ask for tv to be removed.
