Findings/Comments Here for renewal inspection. The licensing official met with Shante Hooper, director.

Please complete application and fee online by March 31, 2021. Submit full survey and two week notes by March 01, 2021 to your licensing official.

Deficiency - Rule 1.6.3(8) states in part, "each facility shall maintain a notebook containing copies of the MSDH certification of Immunization Compliance (MSDH Form #121) for both staff and children at the facility."

Findings: Based on observations and review of staff and children records, the facility failed to assure that they had a current MSDH 121 on each employee. Record review revealed one (1) employee record lacked a current MSDH 121 form.

P.O.C.: The owner/director will develop a policy that will ensure that all new employees either have a valid MSDH 121 form within 5 days from the date of employment. This will be monitored by the director.

Kitchen received letter grade "A"

Class I and II violations may result in a monetary penalty. Repeated violations may result in the doubling of a monetary penalty, suspension, or revocation of the license.

Licensing official will follow up on contact hours by 3/01/2021.
