1. **Out of Compliance:** At least one staff member with valid CPR/First Aid certification is onsite. (Rule 1.8.1 Page 38)

Plan of Correction

1. **POC:** Deficiency: Rule 1.8.1 (5) states in part, ???During all hours of operation, including arrival and departure of children, a child care facility employee shall be present who holds a valid First Aid certification, at any location where the children are present.??? Findings: Based on observations during records review of the facility, the facility failed to have a staff member with a valid First Aid certification on site. The director stated to CCFI that they have a training for CPR/ First AID on Thursday, September 7,2023. Upon arrival of the facility CCFI was told that a staff had a valid CPR/FIRST AID but staff member has left the premises. CCFI couldn't verify if staff had a valid CPR/FIRST AID. CCFI will give director 48 hours to submit valid CPR/ FIRST AID to her by email.
