1. POC: The licensing official observed 6-9 inches of surfacing is needed under and around playground red and blue slide. The licensing official observed a pile of surfacing (pea gravel) present on the playground area. Per Stephanie Hendrix, they are in the process of getting the surfacing put down on the playground area. The children should not utilize the red and blue slide until surfacing has been put into place.
