1. **POC:** During the facility inspection, the licensing official observed several holes in the surfacing on the playground. The concrete is exposed around rocking toy and around shade poles. The director will be responsible for ensuring the playground surfacing is repaired. The director will contact maintenance to come out. The director will review MSDH regulations for playground. The expected completion date foe compliance is November 14, 2022. A follow-up will be conducted.
