- 1. **Out of Compliance:** Infants are dressed in clothing appropriate for sleeping without head covering or entrapment. (Rule 1.9.4 Page 42)
- 2. **Out of Compliance:** Room is draft free and room temperature is between 65°F and 78°F. (Rule 1.9.4 Page 42)
- 3. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

4. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)

Infant Classroom - Classroom Number: 1

1. **POC:** During the facility review the license offical observed I child dressed in a short onesie. A heavey blanket was placed over infant in the bed. Technical Assistance was provided on dressing infants in long sleves onesie on cold days before going to sleep. The director /owner will have a meeting with all staff to correct the violation. The licensing offical request that infant teachers take infant regulation with the MSDH. A follow -up will be conducted with-in 14 days.

2. **POC:** The director/owner will be responsible for ensuring that the temperture in the class room for the infants is correct. The temperture in the classroom should be 65 to 78 degrees. The director/owner will have a meeting with the staff to correct the violations. Please send roster to the licensing offical.

3. **POC:** The director/ owner will be responsible for ensuring infants only sleep in beds. The licensing offical observed 1 infant sleep in a bouncer with a blank on the infant. Infants should be placed on their back in cribs with nothing in the bed. A pillow was observed on a empty crib. The director /owner will correct this violation by mointoring each classroom daily. The director will have a staff meeting to correct the violation.

4. **POC:** During the facility meeting the licensing offical observed no label and dates on the bottles. All bottles should be lalabed and dated daily. A review of rule 1. 18.3 shall be reviewed with all staff. The director/ owner will have a staff meeting to correct the violation. Please submit roster to licensing offical. A follow-up will be conducted in 24 days.
